President Cooke thanked Bob for his report.

President's Report – Marilyn Cooke (mcooke614@gmail.com or 770-559-3646):

- > We thanked Dot for the two-speed tables on the opposite side of LCD.
- > It seems that our efforts to get some type of control on the speeders are always met with different obstacles. We informed DOT some time ago that traffic was rerouting up Amalfi to avoid the speed tables on LCD. Well, that traffic seems to be increasing. We have passed this on to DOT, again.
- > We are losing streetlights like they are free. It was suggested that we do not replace the broken ones until the bridge is fixed. We have lost two since the last meeting, both here on the LC causeway.
- > I wrote to Karen Anderson, the grant writer for RCSD as suggested. She does not have any information at this time on any grants for subdivisions for any type of improvements. She gave me the information for the County grant writers & I will reach out to them this week.
- > Missy & I spread out some of the chemicals for the Alligator weed along the causeway on both sides where it is bad. Anywhere else, let us know.
- > John Moretto sent an email stating: The Atlas survey team will be at the bridge site tomorrow doing a ground-penetrating radar survey of both bridge approaches. This should all be conducted within the road right of way.

Vice President: Ashley Baird (770-862-4572): Nothing to report.

Committee Reports:

Beach: Mary Boysworth (678-457-7324 or mboysworth@yahoo.com):

Two loads of white beach sand have been delivered. The Board discussed and approved the order for two more loads. Ways and means for spreading the sand were discussed.

The sidewalks for the Beach are completed and look great. We need to finish removing the stumps from the flower bed, so that Mary can create a children's play area there with a sandbox.

Mary discussed with the Board designating a Handicapped parking spot in the Clubhouse parking lot.

The Beach Bathroom will stay closed for now. This will be reviewed month by month.

Mary is working with a locksmith to determine the best solution for replacing the lock for the Beach restroom.

We need a volunteer to clean the floating dock.

Clubhouse: Missy Jarrell – (770-484-0244 or msnjarrell@comcast.net): Missy and the Board discussed and decided the Clubhouse would be opened for rentals beginning in June. A motion was made to institute the following changes: In addition to the rental fee of \$100 and the refundable rental deposit of \$50, a \$50 non-refundable fee will be added for Covid Sanitizing. Masks will be required, and the maximum occupancy will be limited to 50 persons. This motion was seconded and passed with a unanimous Board vote in favor. There were no votes against and no abstentions. The Board approved the purchase of a sanitizing device for the Clubhouse. The Board discussed issuing-colored cards to members who rent the Clubhouse. Their guests would place these cards visible in their cars which would serve as their credentials for parking in the Clubhouse parking lot during the Clubhouse rental event.

Hospitality: Michelle Lewis-Headley (mslheadley@yahoo.com or 678-910-1088): Michelle thanked Mary and Marilyn for their help with the children's Easter Event. She has posted pictures on Facebook.

Michelle announced the following Lake Capri HOA hospitality event: On Memorial Day, May 31, beginning at 3 pm, members may stop by Clubhouse and receive a boxed lunch of a hot dog, chips, and soda (while supplies last).

Lakes and Dams: Randy Roddenberry (770-713-3290): Not present. Randy is recovering well from recent surgery. Marilyn and Missy have made an initial application of the weed-killing pellets that Randy spoke of last month. Several members offered suggestions of some areas with weed growth in the lakes. Tim volunteered to help.

Landscape: Tim Williams (678-662-8641): Tim attempted to burn the pile of debris from the spring cleanup of the Beach and Clubhouse area, but the material was too wet and only smoldered. When the burn ban is lifted at the end of September, he will burn the debris pile.

Buddy Denman volunteered to replace the American flag outside the Clubhouse.

Tim expressed concern that the excess traffic from the Detour is causing the roadways to break down especially along some of the edges. This can be reported to the DOT since they are in charge of maintaining roadways.

Restrictions: Chip Hatcher (gmahatcher@gmail.com or 678-526-9805): Chip and two Board Members met with a resident on Napoli regarding a decorative metal fence 30 inches high for their front yard. The plan drawings were available at the Board meeting. Chip recommended approval. A motion was made to approve this fencing with the stipulation that it must be installed based on the plans that were presented to the Board. This was seconded and passed with unanimous consent, no one opposed and no abstentions.

A resident on Lake Capri Road wants to install a black vinyl-clad chain link fence five feet high in the backyard. Chip inspected the location and recommended approval. A motion was made to approve, it was seconded, and passed with unanimous consent, no one opposed and no abstentions.

Safety and Maintenance: Buddy Denman (770-826-0233 call or text): Buddy suggested that we replace the toilet in the Clubhouse restroom with a handicapped-style toilet. The Board approved this. Buddy volunteered to install it.

Security: Open Position. Mary Boysworth (678-457-7324 or mboysworth@yahoo.com):

Mary reports that the locksmith she is working with for the Beach restroom doors also does security cameras. She will seek his help with ours since no Member volunteer has come forward to help.

More mailboxes and streetlights have been knocked down. Mary suggests that if residents would get their own cameras on their front doors, it might also help us catch people that are doing this.

A member told of an incident where a resident witnessed someone knock down their mailbox. The Sheriff's Department was called. In another incident, a driver passed a moving car in an illegal and dangerous way. The victim's car was a Tesla with cameras that captured the event. It will be reported to the Sheriff.

The Board discussed changing the Clubhouse lock to use a code instead of a key. This would be better than having to give out the key to renters and get it back, etc. The code could be changed when the rental was over. The Board discussed the problem of Members sharing the Beach gate code with non-members. A member stated that one neighborhood issues a key, one per household, for their swimming area, thus cutting down on those not authorized to use their facilities.
